



1. The date indicated is the date you first meet one of the three qualifications; you can change this date.

2. Enter your beneficiary's birth date.

4. Enter the amount of earned credits at the time of your retirement date

5. Enter your estimated FAS (see 'actual' column)

Options A, B and C will populate. These are gross, monthly amounts.

6. Click "Calc Estimate"

Legend:

Actual

The Actual column will have your current information as of the end of the most recent quarter. Options A, B and C will indicate \$0.00 until your calculation is complete. For the retirement qualifications, click on Help from the Menu and then Benefit Estimator.

Estimated

The estimated column will have zeros until you enter the information. **Earned credits** is the amount of earned service credit by your retirement date. **Allowed credits** is service credit you plan to buy. If you are not buying service credit, leave this field alone. **Total credits** will populate after you enter your earned and allowed credits. **Estimated FAS** is your most current estimated *Final Average Salary*; your Final Average Salary is the average of your highest consecutive five years' salaries that your employer has reported to NMERB as of the end of the most recent quarter.

Earned Credits

You earn service credit by quarters in the fiscal year. The fiscal year is July 1 to June 30. The quarters end in September, December, March and June. Refer to your Member Contribution History report for help on figuring out your earned credits.

Option A, B and C

Options A, B and C are your survivor's benefit options upon retirement.



Application for Retirement

You should obtain this form from your local personnel or business office 60-90 days prior to your planned effective date of retirement. There are four pages in the retirement application, they are: (1) Retirement Application Instructions, (2) Application for Retirement Checklist, (3) Member Information, and (4) the Employer Certification. Complete the Member Information Form and return it to your personnel or business office where the Employer Certification will be completed. Your employer will then forward the completed application to our office. Our staff will review your application for eligibility and mail to you your retirement documents, which include: an information memorandum, a final computation of your retirement benefit, a final selection of benefit form, and a direct deposit authorization form. (The New Mexico Retiree Health Care Authority will automatically mail you a retirement packet. For more information on the NMRHCA, call 1-800-233-2576.)
