## **INSTRUCTIONS**

1. The New Mexico Educational Retirement Board (NMERB) is a qualified plan under section 401(a) of the Internal Revenue Service Code. In accordance with the provisions of the Economic Growth and Tax Relief Reconciliation Act of 2001, effective January 1, 2002, the NMERB will accept a transfer or direct rollover of funds from the following sources:

Eligible Deferred Compensation
 IRC 457(b) (maintained by a governmental employer only—457(e)(17))

Another Qualified Employer Plan IRC 401(a) (including 401(k))

• Tax Sheltered Annuity (TSA) IRC 403(b)(13)

Individual Retirement Account (IRA) IRC 408 (certain restrictions apply; does not include Roth IRAs)

2. The NMERB will only accept a transfer or direct rollover of pre-tax monies.

\*Check is payable to: New Mexico State Treasurer

3. Both the member and the custodian/trustee must complete this form. The custodian/trustee should mail this completed form along with the Payment Transmittal Document and an issued check to the address below. Once the NMERB has received this completed form, the completed Payment Transmittal document and the rollover check from the custodian/trustee, we will notify the member accordingly.
