I hope you are having a great start to 2026. As we begin the new year, I want to share some exciting updates from the Educational Retirement Board (ERB).

We Have a New Home

On December 3, 2025, ERB staff officially moved into our new headquarters. Even though construction took longer than expected due to city delays, we are finally all under one roof! Our Legal, Investments, Administrative Services, Member Services, IT, and

Legislative Update: House Bill 40 (HB40)

The 2026 Legislative Session started on January 20 and runs until February 19. This year, we are watching **House Bill 40 (HB40)**, sponsored by Representative Cynthia Borrego, Representative Nicole Chavez, Representative Joseph Sanchez, and Senator Elizabeth Stefanics.

This bill suggests giving all ERB retirees a **"13th check"** in fiscal years 2027 and 2028. This would be an extra payment on top of your regular monthly checks and yearly cost-of-living increases.

How it works:

The payment would be **2%** of a retiree's total yearly pension.

Example: If a retiree gets \$26,772 a year, their extra check would be about **\$535**.

We are very grateful to the legislators for supporting our members. We hope the Legislature and the Governor will make this a priority.

Modernizing Our Systems

Now that the move is finished, our team is working hard on a new Pension Administration System (PAS). This is the main computer system we use to track member data and send out retirement benefits. This upgrade will help us work faster and serve you better in the future.

Understanding Our 2025 Financial Health

Every year, experts check the health of our retirement fund. They look at how much money is coming in versus how much will be paid out in the future. In December, the Board of Trustees received the latest report for the period ending June 30, 2025.

Think of this report as a **"financial snapshot"** that tells us if we are on the right track to pay all future benefits.

2025 Financial Snapshot

Key Takeaways from the Report

The fund is growing and becoming more stable. Here are the highlights:

- **Growing Membership:** We added **1,304 new workers** to the plan. We also have over **1,000 new retirees**.
- **Strong Investment Gains:** Even though we paid out more in benefits than we collected in dues, the total fund grew by **\$1.2 billion**. This happened because our investments earned a strong **9.8% return**.


- **Better Funding Level:** Our "funded ratio" improved by 3% this year. This measures our assets and compares them to our long-term liabilities.
- **Faster Progress:** We are now expected to reach "full funding" (having 100% of the money needed for all future promises) in **19 years**. That is **3 years sooner** than last year's estimate!

Common Terms Explained

- **Active Payroll:** The total salary of all current workers. ERB takes a percentage of this to help pay for the system.
- **Retiree Payroll:** The total amount of money paid out to retirees and their families.
- **Funding Period:** The amount of time it will take to save enough money to cover all future retirement costs.

The Bottom Line

Your retirement fund is getting stronger. Thanks to smart investments and a growing number of members, we are reaching our long-term goals faster than expected.

Phone Scams: Know the Red Flags. Protect Yourself.

In today's digital world, our telephones keep us connected to the people who matter most. Unfortunately, it's also one of the most common tools used by scammers. These criminals are **professional manipulators** who use fear, urgency, and personal information gathered from social media or public records to sound convincing.

If you know the warning signs, you can stop a scam **before any money is lost**.

1. The "Virtual Kidnapping" or Grandparent Scam

This is perhaps the most frightening scam. You receive a call from someone claiming to be a police officer, a lawyer, or even a kidnapper. They tell you that your grandchild or child has been arrested, injured, or kidnapped, and you must send money immediately to ensure their safety.

- **The Trick:** They may call claiming they have kidnapped your relative and might even play screaming sounds in the background. They may also use "spoofing" to make the caller ID appear as though it's coming from your family member's phone.
- **The Defense:** Never send money immediately. Hang up and call your family member directly on their known phone number. Create a "family code word" that only you and your loved ones know to verify identities in an emergency.

2. Phishing for Your Information

Phishing isn't just for emails; it happens over the phone (often called "vishing"). A caller may pretend to be from Medicare, the Social Security Administration, or your bank. They might claim there is a "problem with your account" or that you are "due for a new card."

- **The Trick:** They will ask you to "verify" your Social Security number, bank details, or birthdate.
- **The Defense:** Legitimate government agencies and banks will never call you out of the blue to ask for your sensitive information. If you're worried, hang up and call the official number found on your actual bank statement or the back of your Medicare card.



3. The "Urgent Problem" Scam

Scammers love to create a crisis. They might claim your computer has a virus (Tech Support Scam) or that you owe back taxes and will be arrested if you don't pay immediately (IRS Scam).

- **The Trick:** They will pressure you to stay on the line and demand payment via gift cards, wire transfers, or cryptocurrency, as these are nearly impossible to trace or refund.
- **The Defense:** No legitimate business or government agency will ever demand payment via a gift card. If a caller is rushing you or threatening you, it is a scam.



Simple Rules to Follow

- Let it go to Voicemail: If you don't recognize the number, don't answer. If it's important, they will leave a message.
- Talk to a Trusted Friend: Before you move any money, call a friend or family member and tell them about the call. Scammers rely on keeping you isolated.



The Golden Rule - Don't trust the Caller ID: Scammers can make it say anything.

- Hang Up & Call Back: If a caller claims to be from a company or government agency, hang up and call the official, publicly listed number (found on your bill, the back of your credit card, or a phone book) to verify the claim.
- It's Okay to be "Rude": You are never required to stay on the phone with a stranger.



Red Flags

- Urgency: "You must act right now!" or "Don't hang up!"
- Secrecy: "Don't tell anyone about this, not even your family."
- Threats: "You will be arrested" or "Your benefits will be cut off."
- Odd Payments: They ask for Gift Cards, Wire Transfers, or Bitcoin.
- Personal Info: They ask for your Social Security number or bank login.



The "Family Emergency" Test

If someone calls claiming a family member is in trouble or kidnapped:

- Stop and Breathe: Scammers use fear to stop you from thinking clearly.
- Ask the Secret Word: Ask for the family "Code Word" (if you've set one up).
- The "Wrong Name" Trick: Use a fake name. For Example, if they are claiming to have your grandson, Ask, "Is this my grandson, Billy?" if your grandson's name is actually Michael. If they say "Yes," it's a scam.
- Hang Up and Call Back: Call that family member directly on their known number to verify they are safe.
